Do you know about? The Accessibility for Manitobans Act

Manitoba's Accessibility Standard for Customer Service under The Accessibility for Manitobans Act, is the first building block of the act and will come into full effect November 1, 2018. Accessible customer service is not necessarily just about ramps or automatic door openers, it is also about understanding that we as customers and clients have a variety of needs. Accessible customer service means that organizations and businesses provide products or services in an efficient, fair and respectful manner to people of all abilities.

An accessibility barrier is anything that limits or prevents a person from being able to receive information, services and goods, or to access space or activities such as:

Accessibility barriers which limit or prevent a person from being able to get information, service and goods or to enter a space or be part of an activity.

Attitude barriers, including stereotypes and assumptions, such as assuming people who cannot communicate verbally have nothing to say.

Accessibility

Physical barriers which prevent people from accessing a service. Examples include store aisles too narrow for a person with a walker or wheelchair, or parking lots without spaces designated for people with disabilities.

Communication barriers that prevent people from understanding information. An example is a sign that is too small or confusing.

Technology barriers often relate to information and communication. An example is a website that cannot be used by people who are blind and use a screen reader.

Systemic barriers are those practices or policies that prevent many customers from accessing your service.
